

Lobby activities for a better funding framework for Culture and Creative Sectors after 2020

Present position: Funding for the main projects remains challenging.

1. INTERREG BSR Funding

- **Status:** Cultural Projects (without innovative or cultural heritage approach) are not eligible in the INTERREG BSR program
- **Demand:** Funding for all objectives and policy areas of the EU Baltic Sea Strategy

2. Specialised EU programs such as ‘Creative Europe’

- **Status:** Funding by specialized EU programs is difficult as no facilitated access for flagships of macroregional strategies is provided
- **Demand:** facilitated access for flagships projects to the specialized EU programs after 2020
